GE Money Bank("Respondent") and a representative of the Division of Finance of the Federal Deposit Insurance Corporation ("FDIC") executed a Stipulation and Consent to the Issuance of an Order to Pay ("CONSENT AGREEMENT") dated January 28, 2009 whereby Respondent, solely for the purpose of this proceeding and without admitting or denying any violation of law for which civil money penalties may be assessed, consented and agreed to pay civil money penalties in the amount specified below to the Treasury of the United States.

The Respondent shall pay the civil money penalty in the form of an ACH debit to the account specified by the Respondent for the next quarterly assessment, due on March 30, 2009.
