Banks

Name & Location

- Find out if your bank is FDIC-insured
- Find the locations of your bank's branches
- Find out if your bank has merged or been acquired
- Review your bank's history (name changes, relocations, etc.)

- Lists of FDIC-insured banks and their locations
- Comprehensive financial and demographic reports
- Current and historical data back to 1992

Securities Exchange Act Filings

- List of FDIC-supervised bank filings
- Beneficial ownership report filings on Forms 3, 4, and 5 by directors, officers, and principle shareholders of depository institutions with a class of securities registered with the appropriate federal banking agency under the Securities Exchange Act of 1934 (Exchange Act)
- Other securities disclosure documents filed by or pertaining to FDIC-supervised depository institutions with a class of securities registered under the Exchange Act

Peer Group Comparisons Reports

- Compare financial information between institutions based on common characteristics including size, financial performance, location, established date, status (open vs. inactive), charter type (state vs. national, commercial bank vs. savings institution), business specialty, etc.
- Standard comparison reports with predefined financial data
- Create custom peer groups, reports, and downloads

Bank Failures and Assistance

- List of FDIC-insured bank failures and assistance transactions

Find Events & Changes

- Structure changes of banks and branches
- New institutions, relocations, mergers, closings, etc.

- The latest quarterly statistics that define the banking industry and the most recent industry trends

- Aggregate results of the annual Summary of Deposits survey

Annual Historical Bank Data

- Annual statistical information on the banking industry back to 1934

Data Download

Call Reports – FFIEC

- Download bulk data by quarter, or download individual bank Call Reports

Application Programming Interface (API)

- Access FDIC's publicly available bank data using the API
- Bulk download of all records – financial, failures, history, institution, location, and summary data

Customize a Report

- Custom downloads of quarterly financial data back to 1992
- User-defined files

Name & Location

- Download list of banks and locations
- Updated weekly

Aggregate Time Series Data

- Aggregate data for all FDIC-insured institutions for each quarter back to 1984 in downloadable Excel spreadsheet files
- Balance sheet
- Loan performance
- Annual income
- Ratios by asset size group
- Loans to small businesses and small firms
