- ◆ Other securities disclosure documents filed by or pertaining to FDIC-supervised depository institutions with a class of securities registered under the Exchange Act

Deposit Market Share

- ◆ Branch office deposits as of June 30
- ◆ Deposit Market Share reports
- ◆ Pro Forma-HHI – before and after effects of proposed mergers
- ◆ Market Presence Report – market share report for 1 institution
- ◆ Growth Rate – deposit performance report for 1 institution

Comparison Reports – SDI

- ◆ Compare financial information between institutions based on common characteristics including size, financial performance, location, established date, status (open vs. inactive), charter type (state vs. national, commercial bank vs. savings institution), business specialty, etc.
- ◆ Create custom peer groups, reports, and downloads

Standard Industry Reports – SDI

- ◆ Predefined financial reports

Bank Failures

- ◆ Listing of FDIC-insured bank failures and assistance transactions back to 1934

Reports of Structure Changes

- ◆ Structure changes of bank and branches
- ◆ New institutions, relocations, mergers, closings, etc.

- ◆ The latest quarterly statistics that define the banking industry and the most recent industry trends

Deposit Summary Tables

- ◆ Aggregate results of the annual Summary of Deposit Survey

Annual Financial Data

- ◆ Commercial bank, savings institutions and bank failure history

Data Downloads

Call Reports – FFIEC

- ◆ Download bulk data by quarter or individual call reports filed by banks

Quarterly Financial Data – SDI

- ◆ Quarterly financial data for all FDIC-insured institutions
- ◆ Predefined .zip files for all SDI schedules, for each quarter

Custom Financial Data – SDI

- ◆ Custom downloads of quarterly financial data back to 1992
- ◆ User defined files

- ◆ Updated weekly

Quarterly Banking Profile (QBP)

- ◆ Quarterly report card for the banking industry
- ◆ Summarized financial results in the form of analysis, graphs, and statistical tables for all FDIC-insured institutions
- ◆ Results are published approximately 55 days after the end of each quarter beginning with December 31, 1994

FDIC State Profiles

- ◆ Quarterly data sheets of banking and economic conditions for each state
