### Two New Deposit Insurance Publications Available in Korean and Chinese

The Federal Deposit Insurance Corporation (FDIC) has announced that its two new deposit insurance brochures for bank customers – *Insuring Your Deposits* and *Your Insured Deposits: FDIC's Guide to Deposit Insurance Coverage* – are now available in Korean and Chinese (traditional and simplified).

*Insuring Your Deposits* is the FDIC's basic deposit insurance guide for bank customers, covering the four most common account ownership categories (single, joint, payable on death and retirement). *Insuring Your Deposits* is now available the following five languages:

- Korean (FDIC-007-2005),
- Chinese Simplified (FDIC-009-2005)
- Chinese Traditional (FDIC-011-2005).
- Spanish (FDIC-016-2004)
- English (FDIC-002-2004)

*Your Insured Deposits: FDIC's Guide to Deposit Insurance Coverage*, an update of the FDIC's 1999 publication of the same name, is a comprehensive overview of the rules for deposit insurance coverage and is intended for depositors who need detailed information on the deposit insurance rules. *Your Insured Deposits* is now available in the following five languages:

- Korean (FDIC-006-2005),
- Chinese Simplified (FDIC-008-2005)
- Chinese Traditional (FDIC-010-2005)
- Spanish (FDIC-015-2004)
- English (FDIC-001-2004)
