Two New Deposit Insurance Publications Available in Korean and Chinese

The Federal Deposit Insurance Corporation (FDIC) has announced that its two new deposit insurance brochures for bank customers – *Insuring Your Deposits* and *Your Insured Deposits: FDIC's Guide to Deposit Insurance Coverage* – are now available in Korean and Chinese (traditional and simplified).

Insuring Your Deposits is the FDIC's basic deposit insurance guide for bank customers, covering the four most common account ownership categories (single, joint, payable on death and retirement). *Insuring Your Deposits* is now available the following five languages:

- Korean (FDIC-007-2005),
- Chinese Simplified (FDIC-009-2005)
- Chinese Traditional (FDIC-011-2005).
- Spanish (FDIC-016-2004)
- English (FDIC-002-2004)

Your Insured Deposits: FDIC's Guide to Deposit Insurance Coverage, an update of the FDIC's 1999 publication of the same name, is a comprehensive overview of the rules for deposit insurance coverage and is intended for depositors who need detailed information on the deposit insurance rules. *Your Insured Deposits* is now available in the following five languages:

- Chinese Simplified (FDIC-008-2005)
- Chinese Traditional (FDIC-010-2005)
- Spanish (FDIC-015-2004)
- English (FDIC-001-2004)
