SUBJECT: Meeting with Representatives from Various Entities

On February 22, 2019, staff of the Federal Deposit Insurance Corporation ("FDIC"), the Office of the Comptroller of the Currency ("OCC"), and the Board of Governors of the Federal Reserve System ("Board") (collectively, "agencies") met with representatives from various entities at the International Swaps and Derivatives Associations, Inc. ("ISDA") to discuss the interagency notice of proposed rulemaking that proposed to implement the standardized approach for counterparty credit risk to calculate the exposure amount of derivative contracts under the agencies' regulatory capital rule ("NPR" or "proposal"). This NPR was published for comment in the Federal Register on December 17, 2018 (83 FR 64660).

The representatives encouraged the agencies to consider various revisions to the proposal, including different treatment for derivatives end-users and consideration of additional risk mitigants.
