SUBJECT: Meeting with Regulatory Fundamentals Group LLC

On September 14, 2016, staff from the Federal Deposit Insurance Corporation (FDIC), Office of the Comptroller of the Currency (OCC), the Board of Governors of the Federal Reserve System (FRB), the Federal Housing Finance Agency (FHFA), the National Credit Union Administration (NCUA), and the Securities and Exchange Commission (SEC) met with a representative from the Regulatory Fundamentals Group LLC (RFG).
