Hello.

This comment/question is in relation to the Federal Register publication dated 4/11/18 (FR Doc. 2018-07443). A series of changes are being proposed for all Call Reports. I am specifically interested in the FFIEC 031 Call Report. Certain changes being adopted effective for 6/30/18 have not been proposed for the FR Y-9C. A Federal Register publication dated 1/2/18 (FR Doc. 2017-28290) introduced changes to the FR Y-9C which we were adopted as noted in a Federal Register publication dated 3.21.18 (FR Doc. 2018-05666). The Federal Register notification & the draft form available on the Fed's website did not address the changes outlined below on certain schedules of the Call Report for 6/30/18. Lack of consistency among like schedules on the FFIEC 031 & FR Y-9C will create additional burden on institutions. Please advise if similar changes to the schedules noted below are being considered for the FR Y-9C for 6/30/18. Thank you.
