I support the elimination of Part 350 for disclosure of financial and other information by FDIC-Insured State non member banks as purposed. The proposed rule was outlined in FIL-66-2018 by the FDIC. The public has not request this information because of the ease of access to bank's call reports. This information is made public when institutions file the call reports on the FFIEC's website. Additionally, regulatory agencies publicly disclose enforcement actions equal to our requirement to maintain these items in the file. As reference this information takes use about 30 to 45 minutes annually to place in a file.
