On May 6, 2015, FDIC staff (as enumerated on Attachment A) participated in a conference call with staff from the American Bankers Association ("ABA"), representatives of a number of commercial banking organizations, staff from The ClearingHouse and attorneys from the Sullivan & Cromwell LLP law firm. The participants from those organizations and associations are identified and listed on Attachment B as provided by the ABA.

FDIC staff began the conference call with an overview of the Advance Notice of Proposed Rulemaking ("ANPR"). The subsequent discussion addressed a number of matters, including the possible time frame for implementation of certain proposals, if ultimately adopted; the application of the proposals to various types of trust deposit accounts; and the ANPR's relationship to the FDIC's current regulation, 12 CFR 360.9.
