When and where joined the FDIC: In 1992, I was hired by the Legal Division, and was assigned to the Professional Liability Section (PLS) unit. I worked in the 1776 H Street NW, Washington, DC office.

Other experience: I joined the FDIC in 1990 as a term employee at the NBW field office in Washington, DC. I left the agency in 1991, and returned in 1992 as a term employee through the Utility Pool. I was hired the same year by the Legal Division, PLS unit, as a Legal Technician. After five years, my office underwent a reorganization, and I began to look for other opportunities in the agency.
