FDIC Now Has Three Free Lending Libraries

Since 2018, the FDIC has had a book exchange cart outside the main library (Room MB-4055). The idea behind the initiative is to share donations that the library doesn't need for its collections and to make reading even more accessible to the community. The FDIC Library collects and lend materials to support FDIC's core mission and purchases materials to help employees accomplish specific career goals.

This year, due to the program's success and a generous donation from Corporate University, the program is expanding to two locations in Virginia Square. Beginning in September, staff visiting FDIC's Arlington, Virginia, offices will be able to take and exchange books at two locations: the Student Residence Center lobby and in the vicinity of the coffee shop in Building C.

This Free Lending Library program is modeled on the <u>Little Free Library</u> movement. Little Free Libraries offer

communities opportunities to share books with friends and can introduce you to something you might be able to use but didn't even know was available. Little Free Library is a non-profit organization that works to promote reading and expand access to reading materials through book exchanges.

spend some quality time with the family with few distractions to get in the way.


